DALLAS CASA TRAINS AND SUPERVISES COMMUNITY VOLUNTEERS WHO GATHER INFORMATION AND MAKE RECOMMENDATIONS THAT HELP JUDGES DECIDE THE BEST POSSIBLE OUTCOMES FOR CHILDREN WHO HAVE BEEN REMOVED FROM UNSAFE HOMES AND ARE LIVING IN PROTECTIVE CARE. OVER 4,300 ABUSED AND NEGLECTED CHILDREN ARE IN PROTECTIVE CARE EACH YEAR IN DALLAS COUNTY. IN 2017, DALLAS CASA SERVED 3,118 CHILDREN WITH 1,314 ASSIGNED VOLUNTEERS AND AN AGGREGATE OF 672,601 TOTAL DAYS OF SERVICE TO CHILDREN.
